

**1) Promotion: \$10K Football Pick'em Challenge (the "Promotion")**

This Promotion is governed by these terms and conditions (the "**Conditions**") as well as BCLC's General Terms and Conditions for Promotions (the "**General Conditions**"). Where the Conditions and the General Conditions conflict, these Conditions will prevail.

**2) Promotion Period:** 6:00:01 pm PT on August 29<sup>th</sup>, 2025 to 11:59:59 pm PT on January 4<sup>th</sup>, 2026 (the "**Contest Period**").

**3) Prize:** There will be eighteen (18) weekly prizes (each a "**Weekly Prize**") awarded to one (1) winner per week and one (1) grand prize (the "**Grand Prize**"), for a total of 19 prizes available to be won under this Promotion.

Each Weekly Prize consists of:

- \$250 in casino free play
- a NFL jersey as determined by BCLC; and
- an entry into the Grand Prize Draw.

The approximate retail value of each Weekly Prize is \$500.

The Grand Prize consists of:

- \$10,000, which will be paid by cheque.

**4) Participating Facility:** Parq Casino

**5) Qualified Entrant:** in addition to the requirements for a Qualified Entrant in the General Conditions, for this Promotion, the entrant must not be:

- (a) an employee of Parq Casino, JW Marriot, or Parq Blau, or a family and household member of any of the foregoing who is residing at the same address.

**6) How to Enter**

- **Weekly Prize Entry**
  - Entrants must visit the Participating Facility between Tuesdays at 12:00:01 am and Sundays at 9:59:59 am (before kickoff of the Sunday morning NFL games) (such period being the "**Gaming Week**") during the Promotion Period and participate in the Football Pick'em activity by making their picks (team, win, loss or tie, and answering a tiebreaker question) for each NFL game for that week on iPads available at the PROLINE Parq Casino Sportsbook Lounge ("**Weekly Prize Entry**").

- A tie is determined if a game ends within 3.5 points. That means, if the game is decided by a field goal, the game will be considered a tie. This is considered final score, including regulation and overtime.
- Qualified Entrants that place a weekly entry on Thursdays after 4:59:59 pm will not be able to select the outcome of the Thursday Night Football game, as picks lock at kickoff. Such Qualified Entrants will only be able to make picks for NFL games that have not yet started. This includes any games on Thursday, November 27 (Thanksgiving).
- Qualified Entrants may obtain one (1) Weekly Prize Entry per Gaming Week.
- **Grand Prize Draw**
  - Qualified Entrants who have won a Weekly Prize ("**Weekly Prize Winners**") will be invited to return to the Participating Facility on a date determined by BCLC and entered into the Grand Prize Draw.
  - Weekly Prize Winners will have one (1) entry per Weekly Prize that they have won into the Grand Prize Draw.

## **7) Weekly Prize**

- Qualified Entrants will receive one (1) point for every correct answer they select in their Weekly Prize Entry. The Qualified Entrant with the highest points in a Gaming Week will receive the Weekly Prize for that Gaming Week.
- In the event there is a tie for the highest score amongst the Qualified Entrants, the winner will be the Qualified Entrant whose answer to the tiebreaker question, submitted at the time of making their picks, is closest to the correct answer. In the event the tiebreaker question results in a draw, the Qualified Entrant with the earliest selections will be deemed the winner.
- Qualified Entrants may win more than one Weekly Prize.

## **8) Grand Prize Draw**

- **Grand Prize Draw**
  - The draw for the Grand Prize will be conducted in January 2026 (date TBD) and will be conducted by Parq Casino employees at the Participating Facility.

**9) Odds:** Odds of winning a Weekly Prize depends on selections made by a Qualified Entrant in the Weekly Prize Entry during a Gaming Week. The odds of winning the Grand Prize depends on the number of Grand Prize Entries obtained by each Weekly Prize Winner.

**10) No Purchase Necessary:** No purchase is necessary to enter this Promotion.

**11) Conditions of Prize:**

- **Weekly Prize**

- For each Weekly Prize draw, a BCLC representative will attempt to contact the Weekly Prize Drawn Entrant via a telephone call or email, or both, within four (4) business days after the Weekly Prize Drawn Entrant is selected.
- A maximum of three (3) attempts will be made to contact the Weekly Prize Drawn Entrant via telephone call or email.
- The Weekly Prize Drawn Entrant will have seven (7) business days from the initial contact attempt to accept the Weekly Prize. If BCLC is unable to contact a winner, that entrant may be disqualified, and the weekly runner up will be selected to win the Weekly Prize.
- Weekly Prize Drawn Entrant must physical attend the Parq Casino to accept the Weekly Prize within seven (7) business days of initial contact by BCLC or its service providers.
- The Weekly Prize Drawn Entrant must provide government-issued, photographic identification acceptable to BCLC, complete such representations and indemnities as required by BCLC, and correctly answer a skill-testing question in order to receive the Weekly Prize. BCLC reserves the right to disqualify any Qualified Entrant that does not complete each of these conditions.

- **Grand Prize**

- Weekly Prize Winners must be in attendance at Participating Facility in order to win the Grand Prize.
- The Grand Prize Drawn Entrant must provide government-issued, photographic identification acceptable to BCLC, complete such representations and indemnities as required by BCLC, and correctly answer a skill-testing question in order to receive the Grand Prize. BCLC reserves the right to disqualify any Qualified Entrant that does not complete each of these conditions
- If BCLC is unable to determine that a Grand Prize Drawn Entrant meets the requirements of this Contest, the Grand Prize Drawn Entrant will be disqualified, and another entry will be drawn. This process will continue until the Grand Prize is awarded.
- The Grand Prize Drawn Entrant must claim their grand prize immediately at the Participating Facility.
